Catapult + City of Port Adelaide Enfield Mentorship

The Opportunity:

The Catapult + City of Port Adelaide Enfield Mentorship provides a 9-month funded opportunity for a visual artist, crafts practitioner or designer residing in the City of Port Adelaide Enfield.

Catapult is an artist-led mentoring program delivered by Guildhouse since 2018. The program provides a flexible and paid opportunity for artists at all stages of their career to purposefully engage with their chosen mentor, with Guildhouse providing support and facilitation.

Through Catapult, Guildhouse has supported more than 70 artists to pursue tailored learning and growth. South Australian mentees can select a local, national or international mentor to support skill development and the expansion of their practice through fruitful exchange. Robust connections between mentee and mentor, plus clear goals, have proven essential for meaningful outcomes.

The Catapult + City of Port Adelaide Enfield Mentorship is presented in partnership by Guildhouse and the City of Port Adelaide Enfield.

Who is eligible?

This opportunity is only available to South Australian Guildhouse Community or Accredited Members, who reside in the City of Port Adelaide Enfield. Undergraduate students, studying at the time of application or during the mentorship period, are ineligible. Previous recipients of a Catapult mentorship cannot apply. If you previously participated in Catapult as a mentee, you are eligible to be a mentor.

What is included?

The selected applicant will receive \$8,000 administered by Guildhouse and paid directly to the mentee and mentor in two instalments:

- \$7,000 – mentee and mentor fees (including superannuation)
- \$1,000 – to support the development of the City of Port Adelaide Enfield public program outcome

How will applications be assessed?

The panel will include representatives from Guildhouse and our Artist Advisory Group. Applicants will be assessed against the following criteria:

- Goals and plan for how the mentorship will extend your practice
- Outline of applicant's reasoning for applying and expectations
- Track record and readiness for mentorship
- Support material demonstrating artistic ambition and excellence

How do I prepare my application and apply?

Applications are submitted via the [online form](#), and must include:

- **Confirmation of Guildhouse Membership:** Community or Accredited Membership
- **Confirmation that mentee is a City of Port Adelaide Enfield resident**
- **Contact details:** for mentee and confirmed mentor
- **Mentee website and social media (if applicable)**
- **Brief summary:** provide a 30-word outline of the mentorship aims
- **Mentorship Proposal (700 words max):** Outline your proposal and key goals. These might include:
 - the relevance of the mentor to the mentee
 - what you hope to gain and learn from the mentor
 - structure of the mentorship program (how you will connect, discussion plan)
 - share any potential ideas around the City of Port Adelaide Enfield public program outcome
- **Mentorship Timeline (pdf. format):** The Catapult mentorship program is to be completed within a 9-month period. The duration of the mentorship should be designed to align with the mentee's goals. The timeline should provide key milestone events (meetings between mentor and mentee, production of work, critique sessions etc.).
- **Biography:** 200 words each, for mentor and mentee
- **Mentorship Budget (pdf. format):** Prepare a budget that outlines income and expenditure for the mentorship (e.g. travel expenses, mentee/mentor fees, material costs and public program outcome fees). Income would include the Catapult fee and any other funding streams (either personal or otherwise).
- **1 page CV (pdf. format):** for the mentee
- **Support Letter (pdf. format):** A Support Letter from someone with a good understanding of your practice, outlining your suitability for the mentorship. Your proposed mentor cannot write the Support Letter.
- **Support Images (pdf. format):** 5 images of your own work and 1 image indicative of the mentor's practice, collated in a pdf. document with image captions. File must not exceed 10MB. If your practice is video based, include links in your pdf. document with any access requirements to view.
